Contributors

Kevin Aho is Associate Professor of Philosophy at Florida Gulf Coast University. He completed his dissertation on Heidegger under the direction of Charles Guignon at the University of South Florida. He is the author of *Existentialism: An Introduction* (Polity, 2014), *Heidegger's Neglect of the Body* (SUNY Press, 2009), co-author (with James Aho) of *Body Matters: A Phenomenology of Sickness, Illness, and Disease* (Lexington Books, 2008), and co-editor (with Charles Guignon) of *Dostoevsky's Notes from the Underground* (Hackett, 2009). In May of 2014, Charles and Kevin co-convened the 48th Annual Meeting of The Heidegger Circle in St. Petersburg, Florida.

Megan Altman is instructor of philosophy at Hiram College and a Ph.D. candidate in philosophy at the University of South Florida. She is completing her dissertation on Heidegger and moral philosophy under the guidance of Charles Guignon. She is forever indebted to Charles' mentorship and friendship.

Robert C. Bishop is Associate Professor of Physics and Philosophy and the John and Madeleine McIntyre Endowed Professor of Philosophy and History of Science at Wheaton College. Prior to Wheaton, he taught at the London School of Economics, Oxford, and Rice University. He has published in a variety of journals and edited collections including *Studies in the History and Philosophy of Modern Physics*, *Philosophy of Science*, *Journal of Theoretical and Philosophical Psychology*, *International Journal of Physics* and *Interface Focus*. Steven Burgess is a Postdoctoral Instructor at University of South Florida, where he also received his doctoral degree. His dissertation, “Nietzsche and Heidegger on the Cartesian Atomism of Thought”, was written under the direction of Charles Guignon. He recently published an article in *Society and Politics* and has presented his work at a number of international conferences. His current research involves Nietzsche’s view of language and Heidegger’s understanding of truth.

Benjamin Crowe is Assistant Professor (Lecturer) in Philosophy at the University of Utah. He is the author of *Heidegger’s Religious Origins: Destruction and Authenticity* (Indiana, 2006) and *Heidegger’s Phenomenology of Religion: Realism and Cultural Criticism* (Indiana, 2007). His research focuses on questions of religion, ethics and selfhood within the larger German philosophical tradition (including Herder, Fichte, and early Romanticism).

Daniel O. Dahlstrom is the Silber Professor of Philosophy at Boston University and the author of *Das logische Vorurteil* (1994), *Heidegger’s Concept of Truth* (2001), *Philosophical Legacies: Essays on the Thought of Kant, Hegel, and their Contemporaries* (2008), and *The Heidegger Dictionary* (2013). He has also produced a new translation of *Husserl’s Ideas I* (2014) and edited *Interpreting Heidegger: New Essays* (2010). Whenever he thinks of Charlie, he thinks of a soulmate survivor of the sixties.

Blaine J. Fowers is Professor of Counseling Psychology at the University of Miami. He is a Fellow of the American Psychological Association. His primary scholarly interest is centered on the contributions of Aristotle’s ethics to a richer understanding of research and clinical practices in psychology and of ordinary life. He directs the Goal Orientations and Life Success (GOALS) Project, which is focused on documenting the existence and functioning of higher order goals and investigating the links between pursuing choice worthy goods and human flourishing. Fowers came to know Professor Guignon through exchanges about a series of illuminating papers Professor Guignon gave at a variety of psychology conferences and eventually collaborated in writing *Re-envisioning Psychology*. Fowers is also the author of *Virtue and Psychology*, *Beyond the Myth of Marital Happiness*. Currently, he is completing a book entitled *Sociality and the Human Good: Toward a Natural Theory of Ethics*. Fowers has published numerous peer-reviewed articles on the psychology of virtue, practical wisdom, and human flourishing.

Lawrence J. Hatab is Louis I. Jaffe Professor of Philosophy and Eminent Scholar at Old Dominion University. His research has concentrated on Nietzsche, Heidegger, and Ancient Philosophy. He is the author of six books, including *Nietzsche's On the Genealogy of Morality* (Cambridge University Press, 2008), *Nietzsche's Life Sentence: Coming to Terms With Eternal Recurrence* (Routledge, 2005), and *Ethics and Finitude: Heideggerian Contributions to Moral Philosophy* (Rowman & Littlefield, 2000). He met Charles many years ago at a Heidegger Circle meeting and has been an admirer ever since.

William Koch is currently teaching philosophy in the C.U.N.Y. system and completing a book tracing Heidegger's turn away from, and return to, key methodological insights through his career. He is also engaged in a project assessing the changes caused to Heidegger's History of Being by the fuller inclusion of Homer and the shift from orality to writing within it. He has the honor to have had Charles Guignon as his dissertation advisor and to benefit from his guidance and friendship.

Jeff Malpas is Distinguished Professor at the University of Tasmania. He is also Distinguished Visiting Professor at Latrobe University in Melbourne. He is the author or editor of many volumes, including *Heidegger and the Place of Thinking* (MIT, 2012). His first encounter with Charlie was at one of Bert Dreyfus' NEH seminars in Santa Cruz.

Eric S. Nelson is Associate Professor of Philosophy at the University of Massachusetts, Lowell. His research areas include hermeneutics, ethics, and the philosophy of nature. He has published over 60 articles and book chapters on Chinese, German, and Jewish philosophy. He is the co-editor with François Raffoul of the *Bloomsbury Companion to Heidegger* (Bloomsbury, 2013) and *Rethinking Facticity* (SUNY Press, 2008). He has also co-edited with John Drabinski, *Between Levinas and Heidegger* (SUNY Press, 2014); with G. D'Anna and H. Johach, *Anthropologie und Geschichte. Studien zu Wilhelm Dilthey aus Anlass seines 100. Todestages* (Königshausen & Neumann, 2013); and with A. Kapust and K. Still *Addressing Levinas* (Northwestern University Press, 2005). He has edited special topic issues for the *SACP Forum*, the *Journal of Chinese Philosophy*, and *Frontiers of Philosophy in China*.

Mariana Ortega is Professor of Philosophy at John Carroll University, University Heights, OH. She received her Ph.D. from the University of California, San Diego. Her main areas of research are 20th Continental Philosophy, specifically Heideggerian Phenomenology, Latina Feminism and Race Theory. Her research focuses on questions of self and sociality, the question of identity, and visual representations of race. She has published articles in journals such as *Hypatia*, *International Journal of Philosophical Studies*, *International Philosophical Quarterly*, *Radical Philosophy Review* and *Critical Philosophy of Race*. She is co-editor with Linda Martín-Alcoff

of the anthology *Constructing the Nation: A Race and Nationalism Reader* (SUNY Press, 2009). She is currently working on a monograph that elaborates a notion of self as multiplicitous subjectivity in light of existential phenomenological views and Latina feminisms.

Hans Pedersen is Assistant Professor of Philosophy at Indiana University of Pennsylvania in Indiana, PA. He wrote his dissertation on Heidegger and the philosophy of action under Charles Guignon at the University of South Florida, and his writing and research is still focused on this area.

Derk Pereboom is Susan Linn Sage Professor of Philosophy at Cornell University and author of *Living without Free Will* (2001), *Consciousness and the Prospects of Physicalism* (2011), and *Free Will, Agency, and Meaning in Life* (2014). He and Charlie were colleagues for 16 years at the University of Vermont, where they co-edited *Existentialism: Basic Writings* (1995, 2001).

Richard Polt is Professor of Philosophy at Xavier University in Cincinnati, Ohio. He first studied Heidegger with Charles Guignon at the University of California at Berkeley in 1984–1985, and has benefited from Guignon’s help, advice, and insight ever since. Polt is the author of *Heidegger: An Introduction* and *The Emergency of Being: On Heidegger’s “Contributions to Philosophy.”* With Gregory Fried, he has translated Heidegger’s *Introduction to Metaphysics, Being and Truth, and Nature, History, State.* Fried and Polt have also edited *A Companion to Heidegger’s “Introduction to Metaphysics”* and are co-editors of the series *New Heidegger Research.*

Casey Rentmeester is Assistant Professor of Philosophy at Finlandia University in Hancock, MI. He has published on environmental philosophy, Nietzsche’s philosophy, and wrote his doctoral dissertation on the environmental aspects to the late Heidegger’s work under the guidance of Charles Guignon and Martin Schönfeld.

Frank C. Richardson is Emeritus Professor of Educational Psychology at the University of Texas, Austin. He is author or editor of several books, including *Re-envisioning Psychology* and *Critical thinking about Psychology* and the author of many articles and chapters in theoretical psychology and the philosophy of social science. He is a past president of the Society for Theoretical and Philosophical Psychology (Division 24 of the American Psychological Association). He met Charlie Guignon when they were both assistant professors at the University of Texas in the mid-1970s. They have remained colleagues and dear friends ever since and have collaborated on a book and a number of articles over the years.

Frank Schalow is Professor of Philosophy and University Research Professor at the University of New Orleans. He is the author of several books, including *Departures: At the Crossroads between Heidegger and Kant* (2013), *The Incarnality*

of Being: The Earth, Animals, and Nature in Heidegger's Thought (2006), and *The Renewal of the Heidegger-Kant Dialogue* (1992). He is the editor of *Heidegger, Translation, and the Task of Thinking: Essays in Honor of Parvis Emad* (Springer Publishers), and coeditor of the international journal *Heidegger Studies*.

Iain Thomson is Professor of Philosophy at the University of New Mexico. The author of two books and dozens of articles in philosophical journals, essay collections, and reference works, Thomson is a leading expert on the thought of Martin Heidegger. A recipient of the Gunter Starkey Award for Teaching Excellence, he is well known for his ability to bring Heidegger's difficult ideas to life for contemporary readers. Thomson already admired Guignon's written work for its inspiring combination of broad interest, deep insight, and clear expression, then found "Charlie" to be even more impressive in person: Down-to-earth, thoughtful, generous, frank, and funny, Guignon is a genuine paragon of authentic human being.

Mark A. Wrathall is Professor of Philosophy at the University of California, Riverside. He is the author of *Heidegger and Unconcealment: Truth, Language and History* (Cambridge University Press, 2010) and the editor of *The Cambridge Companion to Heidegger's Being and Time* (Cambridge University Press, 2013).

Michael E. Zimmerman is Professor of Philosophy at the University of Colorado at Boulder, after having spent more than 30 years as a philosophy professor at Tulane University in New Orleans. Author of four books and one hundred published articles and book chapters, Zimmerman does research and teaching in Heidegger, Nietzsche, philosophy of technology, transhumanism, environmental philosophy, and Buddhism. He lives in Boulder with his wife and daughter.
